Clear Channel Broadcasting, Inc., KHKS / 106.1 KISSFM, its subsidiaries and affiliated companies (together, the “Company”), will conduct the Contest substantially as described in these rules, and by participating, each participant agrees as follows:

1. Description of Contest/Participation.

A. Dates of Contest: The Contest will begin on or about Thursday, 11/5/09 and end on or about Friday, 11/20/09.

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of participants.

B. How to Enter:

Submit your bill electronically at www.1061kissfm.com. Bills submitted electronically must be verified before payment is made by the station. Alternate way to submit bill: mail to: KISS FM's Pay Your Bills, 14001 N. Dallas Parkway, STE 300, Dallas, TX 75240. Deadline for registration is 6pm on Friday, 11/20/09. Valid contest entries must contain all information requested. Incomplete and/or multiple entries will be disqualified. All mailed entries should include a copy of one bill you would like to have paid off. On-line entries should state the total amount of the bill and if you win, you will be required to present the bill at the time of prize fulfillment.

C. How to Play: First submit your bill, via accepted methods stated above. Once you have submitted a bill, listen each weekday in the 7am, 9am, 11pm, 2pm, 5pm, 7pm CST hours. If your name is called, you have 10 minutes to call back to the station at the phone number announced – either 800-543-3548 OR 214 / 817 787 1061. If the entrant does not call in during the allotted time, the prize will be forfeited and will not be rewarded. The cash prize will be equal to the bill submitted by entrant. 106.1 KISS FM is not responsible for paying a full balance on a statement, only the (monthly) bill.

KHKS-FM is not responsible for any fraudulent claims on accounts left uncovered or undisguised during the bill submission process.

KHKS-FM is not responsible for fees or charges resulting from delinquent accounts on bills submitted for payment during the contest.

2. Prize(s). The prize(s) that may be awarded to the eligible winner(s) are:

Prize: Prize amounts will vary depending on the amount of the bill submitted but will not exceed \$5,000.

All prizes must be redeemed within 30 days of the contest end date. If a winner cannot be contacted or is disqualified, the Company reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion.

3. Eligibility and Limitations. Participants and winner(s) must be U.S. residents at least 16 years old as determined by the Company. A parent or guardian of any participant who is a minor must sign a release on behalf of the minor to be eligible to receive a prize, but the Company reserves the right to refuse to award a prize to or on behalf of any minor. Contestants can bring as many signs as they want and may donate as often as they want in within the specified time period. Only one (1) prize per household for the Contest. Employees of the Company, the Contest's participating sponsors and their advertising agencies, employees of other radio or television stations, and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

4. Telephone and Delivery Disclaimer. 6. Release. By participating in the Contest, each participant and winner waives any and all claims of liability against the Company, its employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize. In order to receive a prize, participants must sign an official waiver form provided by the Company.

7. Taxes. Any valuation of the prize(s) stated above is based on available information provided to the Company, and the value of any prize awarded to a winner may be reported for tax purposes as required by law.
