



**Kidd Kraddick in the Morning
Pay Your Bills Giveaway**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

Kidd Kraddick in the Morning Syndicated Show & Affiliate Stations the "Station(s)" (the "Station / Sponsor") its subsidiaries and affiliated companies (together, the "Company"), will conduct the Contest substantially as described in these rules, and by participating, each participant agree as follows:

1. Contest Dates

The Kidd Kraddick in the Morning Show will be giving you a chance to win the PAY YOUR BILLS contest. (The "Contest") will run from November 2, 2009, 6:00am CST through November 20, 2009 at 10:00am CST – Winner(s) to be announced on or around between 6a-10a CST ("Contest Period").

2. Eligibility

Contest is open to U.S. residents who have a valid government issued passport, at least 16-years old at the beginning of the contest who are living in the 50 United States or the District of Columbia (except without limitation, residents of New York and California, residents located in overseas military installations, Puerto Rico, other U.S. territories or foreign territories) and who have a valid government-issued photo ID, an email address and internet access as of the beginning of the Contest Period. Employees of The Kidd Kraddick in the Morning Show, affiliated radio stations, and each of their respective parent, subsidiary, and affiliated entities, and the members of their immediate families are ineligible to participate or win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related. The Contest is subject to all applicable federal, state, and local laws and regulations. The Contest is void in New York, California, Puerto Rico, in U.S. territories, outside the U.S. and where prohibited. Entrants who have won a prize worth more than \$600 in any Kidd Kraddick in the Morning Show promotion within the past 90 days (from the date won) are ineligible. Entrants who have won a prize worth more than \$1000 or more in any Kidd Kraddick in the Morning Show / Clear Channel promotion within the past 180 days (from the date won) are ineligible. Entrants are ineligible if they have won any prize from Kidd

Kraddick in the Morning Show / Clear Channel Communication within the past 30 days (from the date won).

Only one (1) prizewinner per household is permitted. A parent or guardian of any participant who is a minor in his or her state of residence must sign a release on behalf of the minor in order for the minor to be eligible to receive a prize, but the Sponsor reserves the right to refuse to award a prize to or on behalf of any minor.

Entrants and contestants will be competing with listeners of the Kidd Kraddick in the Morning Show simulcast participating radio stations in multiple markets around the country and each will be calling the same number and/or entering via the same online web address. DUE TO BROADCAST DELAYS FROM THE NETWORK FEED, LISTENERS TO PRE-RECORDED OR TAPE DELAYED AIRING OF KIDD KRADDICK IN THE MORNING SHOW MAY BE UNABLE TO PARTICIPATE IN THE CONTEST.

3. How to Enter

- 1. How to Play:** Entrants do not have to purchase a product to enter or win. A purchase does not increase your chances of winning. Open to legal residents of the 50 United States and the District of Columbia (EXCLUDING WITHOUT LIMITATION, THOSE RESIDENTS IF LOCATED IN AN OVERSEAS MILITARY INSTALLATION, PUERTO RICO, OTHER U.S. TERRITORIES OR FOREIGN TERRITORIES)

who are 16 years of age or older at the beginning of the contest and who have a valid state issued identification, email address and Internet access prior to the beginning of the Promotional Period (as defined below.) Offer void where prohibited by law, taxed, or otherwise restricted. All federal, state and local laws and regulations apply. There are no substitutions for this prize.

Submit your bill electronically at www.kiddlive.com. Bills submitted via email must be verified before payment is made by the Kidd Kraddick in the Morning and Clear Channel Communications. Alternate way to submit bill: mail to: Pay Your Bills, 220 E. Las Colinas Blvd. Ste. C-210 Irving, TX 75039. Deadline for registration is Friday, November 20, 2009 at 9am CST. Valid contest entries must contain all information requested. Incomplete and/or multiple entries will be disqualified. All entries should include a copy of one bill you would like to have paid off. On-line entries should state the total amount of the bill and if you win, you will be required to present the bill at the time of prize fulfillment. Bills submitted in the amount of five thousand dollars or higher will be automatically disqualified.

How to Play: First submit your bill, via accepted methods stated above. Once you have submitted a bill, listen each weekday in the 7A and 9A CST hours. If your name is called, you have 10 minutes to call to the Kidd Kraddick in the Morning show and claim your prize. In the 7A or 9A hours you must call back to 1-800-543-3548. If the entrant does not call in during the allotted time, the prize will be forfeited and will not be rewarded. The cash prize will be equal to the monthly bill submitted by entrant. Kidd Kraddick in the Morning is not responsible for paying a full balance on a statement, only the (monthly) bill.

Kidd Kraddick in the Morning is not responsible for any fraudulent claims on accounts left uncovered or undisguised during the bill submission process.

Kidd Kraddick in the Morning is not responsible for fees or charges resulting from delinquent accounts on bills submitted for payment during the contest.

Prizes

Prize amounts will vary depending on the amount of the bill submitted. All prizes must be redeemed within 30 days of the contest end date. If a winner cannot be contacted or is disqualified, Kidd Kraddick and the Morning and Clear Channel Communications reserve the right to determine an alternate winner or not to award that winner's prize, in its sole discretion. to determine an alternate winner or not to award that winner's prize, in its sole discretion.

6. Release

By participating in the Contest, each participant and winner waives any and all claims of liability against The Kidd Kraddick in the Morning Show, its employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize. 7. Taxes

The Kidd Kraddick in the Morning Show will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of The Kidd Kraddick in the Morning Show, The Kidd Kraddick in the Morning Show reserves the right to terminate this Contest, or make such other decisions regarding the outcome as The Kidd Kraddick in the Morning Show deems appropriate. All decisions will be made by The Kidd Kraddick in the Morning Show and are final. The Kidd Kraddick in the Morning Show may waive any of these rules in its sole discretion.

9. Miscellaneous

Station(s) shall follow the applicable laws for conducting contests, including notice to the state attorney general or consumer affairs office, posting of a prize bond, furnishing lists of winners, running specific on-air disclaimers, providing specific written information about the Contest, etc. as required by local, state and federal law. Texas law will govern the interpretation of this agreement, and any legal action involving The Kidd Kraddick in the Morning Show will be heard in Texas state court sitting in Dallas, TX

Kidd Kraddick in the Morning reserves the right to change or amend these rules at any time without prior notice.
